ADDITIONAL REQUIREMENTS.

1. Forty-eight hours must be earned outside the College of Business (Economics 1113, 1123 may be counted as outside).
2. 3000-level core courses must be completed to enroll in 4000-level business courses.
3. One upper-division course in each of the following areas is required: FIN, LS, MGT, and MKT.
4. Pass/No Pass **WILL NOT** be accepted for any Business or General Education courses or any specifically required courses.
5. Students must complete the GMAT exam with a score of 500 or greater.
6. Comprehensive written exam required at end of program.
